I understand that, despite The Dog's Day, LLC ("Dog's Day") efforts to maintain the safety of every dog and human at Dog's Day's facilities, there are certain risks involved in doggie day care. These risks include but are not limited to my dog getting injured during an altercation with another dog and my dog contracting fleas, kennel cough or some other communicable illness. I voluntarily accept these risks, and release Dog's Day and its employees, independent contractors, owners and assigns from any and all claims arising out of injury or damage in any way related to or resulting from my association with Dog's Day, including but not limited to claims of injuries to my dog, myself or anyone I send to pick up or drop off my dog, or to any property that belongs to me. I understand and agree that dogs are unpredictable animals and that if my dog becomes injured while at Dog's Day I will be responsible for my dog's veterinary bills and any other costs incurred due to the injury. I represent that my dog is currently in good health and has not had any communicable illness of any kind for one week prior to attending Dog's Day. I further represent that each time I bring my dog to Dog's Day, I am re-certifying that my dog is in good health and has not had any communicable illness of any kind for one week prior to such attendance. I represent that my dog is currently protected by a flea care preventative and that my dog will be protected by this preventative throughout each and every day my dog attends Dog's Day, each time I bring my dog to Dog's Day. I represent that my dog does not have a history of aggressive behavior towards other dogs or humans.

Additional conditions and understandings - Read and initial each line below:

- _____ Dogs not familiar with Dog's Day may experience separation anxiety when apart from their human companions.
- _____ Dogs not regularly exposed to the level of activity at Dog's Day may feel the discomfort of sore muscles, sore joints and fatigue.
- _____ Dogs not regularly exposed to outside activity or play on hard surfaces may experience sore paws, blisters, bruises or abrasions on the feet (Raw Paw).
- _____ Dogs not regularly socialized do not necessarily know how to behave politely with other dogs. These dogs are at higher risk of incidents including, but not limited to, bites, fights, fear aggression, object guarding, behavior problems and/or acting out.
- _____ Dogs at play during the regular day care do get dirty. Dogs with longer hair can get matted from the level of activity at day care.
- _____ Baths and brush outs can be requested and scheduled.
- _____ Excessively long toenails may cause injury. You will be notified if your dog's nails are too long. If, at your next visit, the nails have not been trimmed, Dog's Day will have them trimmed at parent's expense.
- _____ I understand the extra risks my puppy has of contracting disease or illness by entering the day care program without being fully vaccinated.
- _____ Water is available at all times; however, your dog may still be thirsty after day care. Be aware of their water intake as excessive amounts may cause an upset stomach or other problems.
- _____ Dramatic changes in food and/or food quality may cause upset stomachs, diarrhea, and/or colitis.
- _____ Any behavior deemed dangerous or inappropriate by Dog's Day may result in dismissal from the program.
- _____ I agree to pay for all services due at the time they are rendered. I understand any unpaid fees by me will be sent to collections and I will be responsible for all collections and legal fees incurred by such actions taken.
- _____ I have read and understand the Dog's Day "Rules and Regulations."
- _____ I understand Dog's Day staff give all pets involved in any type of incident a cursory examination, however, Dog's Day is not liable for the location, treatment or diagnosis of any injuries incurred on our premises. It is recommended you check your dog further or seek treatment for your pet by a licensed veterinarian at your discretion and cost.
- _____ At The Dog's Day, LLC, photographs may and will be taken of the facility, dogs and staff on a regular basis for use in advertising the services provided by Dog's Day. I hereby give my permission to copyright and/or use, reuse and/or publish or post pictures of me and/or my pet in color or black and white made through any media by Dog's Day for their purpose, including, but not limited to, the use in print material, electronic media or internet usage.
